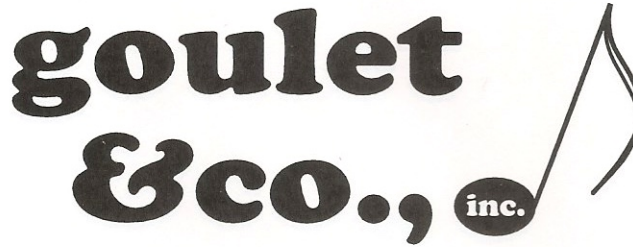

### TERMS AND CONDITIONS

1. All rental payments are payable in advance.
2. There will be no full or partial refund.
3. Goulet & Co. shall retain ownership of the instruments throughout the rental period. I agree not to sell, mortgage, or transfer possession of the instrument until it is confirmed paid in full.
4. **I may terminate this agreement at any time provided I first contact customer service for return instructions.**
5. I will advise Goulet & Co., in writing, of any change of address or phone number.
6. I agree to pay any and all attorney, collection and/or court cost incurred by Goulet & Co. in the process of regaining possession of the instrument and/or any past due payments.
7. A portion of the monthly payment covers the R&R program as outlined below, and is not credited toward the payoff of the instrument under this rent-to-own agreement.
8. There will be a fifteen dollar service charge on any check returned as unpaid by the customer's bank for any reason.
9. **Rental payments continue throughout the summer months.**

### COMPREHENSIVE REPAIR & REPLACEMENT PROGRAM (R & R PROGRAM)

**LOSS:** *Fees cover the loss of the instrument through fire or theft only. Claim of loss must be accompanied by a copy of the police report filed within 24 hours of such loss. Instruments will be replaced with one equal of quality and value.*

**REPAIR:** *We will at no additional cost to you, perform all repairs necessary to keep this instrument in proper playing condition. Cosmetic damage that does not effect playing condition is not covered under this police, nor is abuse. Excluded from coverage are instrument cases, drum heads, drum sticks, bow rehairing and replacement of expendable accessories (\*reeds, mouthpieces, oil, strings, etc.)*
